**Opinion**

We have audited the accompanying Statement of Financial Results of Dudhoria Construction Co Ltd. ('the Company') for the Quarter ended 31st March, 2022 and the year to date results for the period 1st April, 2021 to 31st March, 2022, attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

**Basis for Opinion**
